## Subject of contract

### §1 Scope of Services

The operational services GmbH & Co. KG (OS) supports and administrates partners of the Volkswagen Group as exclusively authorized service provider of Volkswagen AG regarding setup of network connections to the partner network of Volkswagen (VW PFN) and/or to the partner network of Audi (Audi PFN). At Audi this type of network connection is referred to as "AP 2" (Anbindungs-Paket 2).

This connection enables you to use different applications and services of the Volkswagen Group for collaboration and data exchange with its Group brands.

The OS acts as your contact partner regarding all questions, problems and requests:

- Single point of contact (SPoC): Service Support Center of operational services GmbH & Co. KG with services regarding incident management and processing of administrative activities (service requests)
- Service numbers: 0800 5 877 877 (free of charge within Germany) and +49 375 6061 9904 (international) to record incidents and requests during the agreed service times
- Comprehensive consulting services regarding service portfolio and technical network connection types
- Setup, documentation and testing (based on TCP/IP) of the network connection and handover to operation
- Verification of compliance with requirements of the Volkswagen Group

Preconditions for connection of a partner of the Volkswagen Group to the Volkswagen and/or Audi partner network due to Volkswagen Group guidelines are:

#### Non-Disclosure Agreement (NDA):

For connection to the Volkswagen and/or Audi partner network a valid NDA with at least one commissioning Group brand is mandatory. A NDA is required per legally independent acting company that has its own legal form, tax number and/or value added tax identification number (VAT ID number).

#### Information security assessment:

The proof of appropriate information security by a TISAX® assessment is a precondition for the technical connection to the partner networks of Volkswagen and/or Audi. TISAX® creates competition under certified audit providers and enables a mutual recognition of the assessment results within the automobile industry. The successful information security assessment is to be proved by the partner of the Volkswagen Group for each of its locations (per company address).

#### Net provider:

Data exchange or the usage of services of the Volkswagen Group is only possible by using predefined connection types and certified net providers. ### §3 Inception of Contract

The contract period starts with signing this CSN contract by the OS, but not before setup of the technical connection (connection to Volkswagen and/or Audi partner network) by the OS. The change to a higher-value CSN contract type is possible at any time, conversely, only according to CSN contract termination conditions (see §4).

### §4 Contract Period and Termination of the Contract

The contract is concluded for an indefinite period of time. The contract can be terminated with a notice period of three months to the end of the quarter. To become effective the revocation of the contract has to be in writing and must be legally signed.

According to Volkswagen Group requirements a process of deactivation of relevant application access(es) becomes effective, if the following applies:

- No prompt renewal of the NDA (Non-Disclosure Agreement) with the Volkswagen Group
- Violation of the NDA with the Volkswagen Group
- The release for relevant location(s) of the customer concerning information security was not extended in due time

- Delayed payment of contract price

Furthermore the complete deactivation of the technical connection and the cancellation of the CSN contract will take place.

At the request of the Volkswagen Group, the operational services GmbH & Co. KG is entitled to cancel this CSN contract at any time with immediate effect.

## **§5 Accounting**

All regular amounts are charged yearly in advance. The invoice is rendered at the beginning of the year in which the services are provided. If the contract period starts within a current year, the amounts due for this year are charged pro rata. In the event of termination in due time, any overpaid amounts will be refunded.

One-time amounts as well as other services are charged directly after implementation.

All payments need to be done without deduction within 30 days from the date of invoice and have to be free of transaction costs for the OS.

If any tax or duty has to be withheld or deducted from any payment under this agreement, the customer increases payments under this agreement by such amount as shall ensure that after such withholding or deduction the contractor (OS) receives an amount equal to the agreed prices.

## **§6 Price Setting and Price Change**

The price quoted is net plus the statutory sales tax applicable at the time the relevant invoice is issued and will be charged in Euro (€).

## **§7 General Terms and Conditions**

The document General Terms and Conditions ICT services (GTC ICT services) of the operational services GmbH & Co. KG shall apply, according to annex of this contract. In the event of contradictions, the agreements of this contract shall take precedence over the GTC ICT services.

## **§8 Customer's Obligation to provide Assistance and Support**

The customer is obliged to immediately notify the operational services GmbH & Co. KG of any occurrences or changes that could have an impact on the implementation of this contract, with particular regard to any changes of customer's legal status or customer's name or any staff changes which affect this contract.

## **§9 Routing Defaults**

The routing of the network connection of Volkswagen / Audi (internal transmission) to third parties is only allowed if the routing takes place within the company network of the customer and exclusively via and towards company locations of the customer that have received an approval for information security according to TISAX<sup>®</sup> requirements.

The approval must be at least equal to that required for the necessary confidentiality classification (internal / confidential / secret) of the exchanged information.

The connections to other company locations of the customer must be encrypted by the customer (customer has to hold the key).

In case the company location that is connected via routing is legally independent within a group of companies the conclusion of both a CSN first contract and a PDM contract for application services is required.

## §10 Confidentiality of Information

When handling data, information and systems of the Volkswagen Group, the confidentiality requirements and the guidelines for third parties of the Volkswagen Group must always be observed and complied with.

operational services GmbH & Co. KG shall be obligated to treat the information received from the customer strictly confidential towards third parties and to use it only for the services to be provided in accordance with this contract.

No third parties within the meaning of these regulations are the Volkswagen Group and its group companies.
